Transcripts are kept in electronic form for 30 years. All student files are confidential and are available only to the administrative staff and the student.

Expulsion Policy

Refund Policy _____ Initial Here

The application fee, assessment fee and shipping fees are non-refundable. A full refund of tuition fees, if cancellation is received in writing with 10 days from commencement of program. All unused curriculum must be returned prior to refund being issued, if applicable. A 15% restocking fee will apply to all current textbooks purchased from EIN and returned in resalable condition within 20 days from date of cancellation. A 50% refund on unused tuition fees if cancellation is received with 30 days from commencement of program. Withdrawal after 30 days results in no tuition refund.

Student Complaint Procedure

The Edison Institute of Nutrition provides an opportunity for students to resolve disputes of a serious nature in a fair and equitable manner. Once the complaint is received and reviewed the student will be contacted within 48 hours, the student will have the opportunity to verbally submit and discuss further information and concerns.

The necessary inquiries and/or investigations shall be conducted, and the co-director will do one of the following within 10 school days:

- I. If it is determined that the student's concerns are not substantiated, Edison Institute will provide a written explanation of the decision and deny the complaint; or
- II. If it is determined that the student's concerns are substantiated in whole or in part, the Institution will provide a written explanation and propose a resolution
- III. If the student is not satisfied with the dispute outcome at this level, the student may meet with Lynne Hinton Co Director, at the above contact information to discuss the dispute with an outline for resolution
